State Asset Forfeiture FY2010/11

In accordance with OCGA Statute 16-13-49, Civil Asset Forfeitures, this is the annual report for fiscal year 2010/11 documenting all seized currency and property by the LaGrange Police Department. The report also includes the disposition of seized property and expenditures from the condemnation accounts (state and federal). The beginning balance for this fiscal year in the state account was twenty one thousand nine hundred three dollars and thirty two cents. Six thousand four hundred forty two dollars and forty seven cents was received as a result of cases being disposed of during 2010/11. The department spent a total of twenty six thousand, seven hundred sixty one dollars and sixty two cents on equipment, training, travel for training, and legal notices. Our balance as of June 30, 2011 is \$1,584.17 in the State Forfeiture Account.

The beginning balance for this fiscal year in the Federal account was \$2,128.26. Thirty eight thousand five hundred thirty three dollars and thirty seven cents was received as a result of cases being disposed during 2010/11, resulting in a total income of \$40,661.63. The department spent thirteen thousand three hundred fifty one and ninety cents on equipment, training, and travel for training during the year. Our current balance as of June 30, 2011 is twenty seven thousand three hundred nine and seventy three cents in the Federal Forfeiture Account.

We currently have six seizures pending. There are four vehicles, and a total of eleven thousand seven hundred ninety four dollars and thirty four cents in U.S. currency which have not been disposed of in court. Two of the vehicles that are pending condemnation are being condemned federally. The remainder of the cases are state cases.

You will find attached to this memorandum an excel ledger of the funds received and expended from both the State and Federal forfeiture fund this fiscal year. If you have any questions, please contact me.
