As per Georgia statute OCGA16-13-49, Civil Asset Forfeitures, we are required to report annually any monies seized by our unit and the disposition of those items for the fiscal year. Our beginning balance for the **State Seizure Account** was \$76,199.84. In addition to the \$65,082.00 in seized funds received this fiscal year, the account has earned interest in the amount of \$110.27. Our records indicate numerous expenditures in the amount of \$4,186.36 during this reporting period to include payments to the District Attorney's office, court fees, and seizure advertising fees.

Our beginning balance for the **State Forfeiture Account** was \$130,447.65. In addition to the \$42,781.51 in forfeited funds received, the account earned interest in the amount of \$237.42. Additionally, funds were moved in the amount of \$60,927.30 to the Operating account and the Reserve Account to cover operating expenses, as well as equipment and surveillance equipment purchases and two vehicle purchases, resulting in an ending balance of \$112,539.28. (See attached expense summary).

The beginning balance for the West Metro Regional Drug Enforcement Office **Federal Forfeiture Account** was \$44,286.64 as July 1, 2012. In addition to the \$5,419.78 in Federal forfeited funds received this fiscal year, the account has earned interest in the amount of \$47.14. No Federal Forfeiture funds were spent during this fiscal year. The ending available balance for this account as of June 30, 2013 was \$49,753.56.
