Reference: State and Federal Asset Forfeiture Report through June 2014

As per Georgia statute OCGA16-13-49, Civil Asset Forfeitures, we are required to report annually any monies seized by our unit and the disposition of those items for the fiscal year. On July 1, 2013, our beginning balance for the **State Seizure Account** was \$92,496.65. In addition to the \$95,378.05 in seized funds received this fiscal year, the account has earned interest in the amount of \$131.62. Our records indicate numerous expenditures in the amount of \$38,027.38 during this reporting period to include payments to the District Attorney's office, court fees, seizure advertising fees and one Return to Defendant expenditure.

Our beginning balance for the **State Forfeiture Account** was \$112,539.28. In addition to the \$31,505.59 in forfeited funds received, the account earned interest in the amount of \$120.78. Additionally, funds were transferred in the amount of \$24,814.54 to the Operating account and the Reserve Account to cover surveillance equipment purchases and five rifles, resulting in an ending balance of \$119,359.51. (See attached expense summary).

The beginning balance for the West Metro Regional Drug Enforcement Office **Federal Forfeiture Account** was \$49,753.56 as July 1, 2013. In addition to the \$163,847.27 in Federal forfeited funds received this fiscal year, the account has earned interest in the amount of \$72.19. Additionally, funds were moved to the Operating Account to cover one vehicle purchase and renew the Cellbrite cell phone extracting equipment contract. The ending available balance for this account as of June 30, 2014 was \$169,936.03.
