The following report is submitted in accordance with O.C.G.A. § 16-13-49, Civil Asset Forfeitures. This report is for the fiscal year of 2015. Our beginning balance for the State Forfeiture Account was \$49,514.71. We received \$54,406.75 in forfeitures and \$50.35 in interest. Our expenditures were \$36,246.10 (see attached check register). The ending balance as of 06/30/2015 was \$67,725.71.

The beginning balance for the Federal Forfeiture Account was \$56,116.52. Federal forfeited funds received were \$78,419.09. Expenditures for this account were \$61,021.00. The ending balance as of 06/30/2015 was \$73,514.61
