State/Federal Asset Forfeiture FY 2015/2016

In accordance with OCGA Statute 16-13-49, Civil Asset Forfeitures, this is the annual report for fiscal year 2015/16 documenting all seized currency and property by the LaGrange Police Department. The report also includes the disposition of seized property and expenditures from the condemnation accounts (state and federal). The beginning balance for this fiscal year in the state account was \$28,736.61. \$14826.00 was received as a result of cases being disposed during 2015/2016. The department spent \$22,544.01 on publication fees, district attorney fees, equipment, and travel for training. The balance at the end of the fiscal year for the State Forfeiture Account was \$30,995.63.

The beginning balance for this fiscal year in the Federal account was \$2, 429.46. No money or property was received from Federal Condemnation process during 2015/16. No money was spent from the account during the 2015/2016 fiscal year. Our current balance is \$2, 429.46 in the Federal Forfeiture Account..

The department has 12 pending cases (as of June 30, 2016) where cash seizures were made. The total amount pending in these cases is \$17,112.47.

You will find attached to this memorandum an excel ledger of the funds received and expended from both the State and Federal forfeiture fund this fiscal year. If you have any questions, please contact me.
