The proposed budget for Oglethorpe County, Georgia for the fiscal year beginning January 1, 2021 and ending December 31, 2021 was submitted to the Board of Commissioners on August 25, 2020.

A copy of the proposed budget is posted at the Administrative Building at 105 Union Point Street in Lexington, GA. The proposed budget is available for inspection by the general public at the Administrative Building between the hours of 8:00 AM and 5:00 PM Monday through Friday.

A public hearing to consider the proposed budget for 2021 will be held at the Administrative Building board room on September 8, 2020 at 6 PM. All persons wishing to be heard concerning the proposed budget may appear and make their comments.

The budget resolution for the fiscal year commencing January 1, 2021 and ending December 31, 2021 will be adopted by the Board of Commissioners at a meeting at the Administrative Building board room to be held on September 24, 2020 at 6 PM.
